Sub: Starting of Dental College by Academy of Liberal  
Education, Raichur, for the year 1991-92.

Ref: Your letter No.GVG/VMV/90-91/6256, dated 30-3-91.

With reference to the above, I am directed to state that in exercise of the powers conferred under section 53 of Sub-Section 5 of the Karnataka State Universities Act, 1976, subject to approval of the Dental Council of India and without seeking any assistance from the State Government, Sanction is accorded for the year 1991-92 for starting of Dental College by Academy of Liberal Education, Raichur, with an intake of 40 seats for First year B.D.S. Course with the following sanction.

- a) They must have their own building in next two years time with adequate facilities for Laboratories, Libraries, Class Rooms equipment and adequate teachers in various subject.
- b) They must get the clinical facilities at the earliest and intimate to University and the Government as to where they will be wanting the clinical facilities.
- c) They must get the affiliation from Gulbarga University and abide by the terms and conditions that the University may fix to attain the standards prescribed by the University.
- d) They should be prepared to abide by and fulfil whatever any other conditions are laid down by the University and the Government while sanctioning the institution.
- e) They must get recognition from the Dental Council of India as early as possible.

The Government of Karnataka have already issued the Essentiality and Feasibility Certificate to AME's Dental College and Hospital, Raichur for starting of above mentioned MDS courses afresh from the academic year 2012-13 vide reference (2) above.

Principal, AME's Dental College & Hospital, Raichur has requested for issue of the Essentiality and Feasibility Certificate for starting of above MDS courses afresh and increase in intake of MDS courses as indicated against the courses from the academic year 2013-14 at AME's Dental College and Hospital, Raichur in Form-4 of DCI regulations vide reference (3) above.

Government of Karnataka have considered the recommendation of the Syndicate of the Rajiv Gandhi University of Health Sciences, Bangalore and decided to issue the Essentiality Certificate and Feasibility Certificate for starting of above mentioned MDS courses afresh and increase in intake of MDS courses as indicated against the courses from the academic year 2013-14 subject to the condition that the institution shall give an undertaking in the form of a MOU to the effect that the percentage of seats that will be determined from time to time shall be surrendered to Government of Karnataka quota as per consensual agreement that will be entered into from time to time.

Therefore, as per Section 10 A of the Dentists' Act, 1948 read with Regulation 6 (4) of the Dental Council of India (Establishment of New Dental Colleges, opening of new or higher course of study or Training and increase of admissions capacity in Dental Colleges) Regulations 2006, the Government of Karnataka hereby grants the revised Essentiality and Feasibility Certificate for starting of above MDS courses afresh and increase in intake of MDS courses as indicated against the courses from the academic year 2013-14 and onwards to AME's Dental College & Hospital, Raichur in the prescribed format as below:
